Mission of the California Department of Food and Agriculture: To Promote and Protect California Agriculture.

To prevent the introduction and spread of injurious insects or animal pests, plant diseases, & <u>noxious weeds</u>.

Emphasis on: croplands, rangeland, orchards, vineyards, nurseries, and production forests

✓ Overlap with more traditional wildland weeds

The Calif. Dept. of Food and Ag Pest Rating System:

- A- *Incipient populations* mandatory eradication, containment, rejection, or other holding action at the State-County level
- **B-** <u>Regional</u>, action at discretion of Agricultural Commissioner's Office ; mandatory in nursery **C-** <u>Widespread</u>, action at discretion of Agricultural
- Commissioner's Office
- **D-** All other weeds.
- **Q-** <u>*New Pest*</u>, no official A,B,C rating yet, "holding pattern"; treated like an "A"



Yellowspine thistl

A-Rated Noxious Weed =

- Limited distribution; NOT widespread
 Difficult to control; Limited tools
 What the weed has done elsewhere
 Several other factors
- **A-Rated:** mandatory eradication, containment, rejection, or other holding action at the State-County level

A-Rated Weed Status Check

15 A-rated weeds eradicated to date 6 A-rated weeds approaching eradication Currently 27 A-rated weeds in California

Statewide Eradication is Possible!

As evidence, 15 A-rated weed species have been eradicated statewide.

Examples include:

*wild marigold*smooth groundcherry*Syrian beancaper*dudaim melon*serrate spurge*blue weed



Not to mention MANY county/regional eradications.

* From Nine Counties for Hydrilla alone...

You Say Big Deal... you have never even heard of any of these "Ag" weeds. MY POINT EXACTLY.

Six More Weeds Close to Eradication! These A-rated weeds have already been eradicated from most counties in the State...

*golden thistle (only 1 site left in Alameda County!) *perennial sowthistle *plumeless thistle *yellowspine thistle *wavyleaf thistle *Taurian thistle



Again, weeds that YOU likely would be contending with right now if the County Ag Commissioner's and California Dept. of Food and Ag had not implemented an eradication program for A-rated weeds.

Mapping and Database System

Some Final Thoughts...

California has a unique and coordinated noxious weed program/system. District Biologist and County Ag Offices are out there 365 days a year forcing A-rated Noxious Weed populations to eradication.

Eradication of incipient populations of A-rated Noxious Weeds is possible. Continued successes are tallied each year.

* Future eradication successes will take the energies of the California Dept. of Food and Ag, County Ag Offices, Weed Management Area groups, Resource Agencies, and <u>most certainly the CONTINUED efforts of Cal EPPC</u>!

Year 4: 1 plant and progeny. → 2 million seed Year 10: 5 trillion seed; 36,000 acres infested!
