2008 Cal-IPC Symposium Presenter Instructions (updated 7/17)

Thank you for participating in the 2008 Cal-IPC Symposium, October 2-4 in Chico! For 16 years, the Symposium has served as the premier venue for researchers, land managers, and concerned citizens to share information on the latest in invasive plant biology, management, and related issues. Symposium Proceedings provide a permanent record of the information shared during the conference, and are posted online accessible to all.

Deadlines

- ✓ **July 1:** Abstracts for oral and poster presentations due to Cal-IPC. Submit abstracts as an email attachment to Elizabeth Brusati, edbrusati@cal-ipc.org following instructions and template provided at www.cal-ipc.org/symposia/presenters.php.
- ✓ **September 5:** Early registration deadline. All presenters must register, unless you have made other arrangements with the program chair. One registrant per talk or poster receives a presenter discount.
- ✓ **September 19:** Proceedings submission (1000-1500 words) due from all speakers. See below.
- ✓ **October 2:** Turn in your talk or poster file on a CD at the Speakers Table during registration.

Talks

- **Speakers are required to submit an article for the Symposium Proceedings.** Instructions below.
- **Speaking slots are limited.** Submissions not accepted for an oral presentation will be moved to the poster session.
- **Oral presentations are scheduled every 20 minutes.** Time your talk for 15 minutes, allowing time for questions. Session moderators will be instructed to keep presentations on schedule.
- **We use PowerPoint format** for presentations. (Contact us if you would like to use media other than PowerPoint.) Name your presentation file in the following format: "SessionNumber LastName.ppt" (ex. "6 Brusati"). If you are using PowerPoint 2007, "save as" an earlier generation to make sure the file opens on the computer used for projection.
- **Bring your presentation to the Speakers' Table on a CD or USB drive** during morning registration on October 2. If you are not able to do this, contact Elizabeth Brusati prior to the Symposium to make other arrangements
- **PDF files of talks and posters are posted** on the Cal-IPC website after the Symposium. If you do not want your talk posted, let us know at the Speakers' Table when you turn in your talk.

Posters

- **Poster size may be up to 3 feet x 4 feet** (either orientation). We will provide a display board and fasteners for mounting your poster. Bring anything additional or special that your display may need.
- **Set up your poster** from 7:00 am - 9:00 am Thursday, Oct. 2. Posters will be displayed in the Bell Memorial Union throughout the Symposium. There will be a dedicated poster session Thursday, 1-2pm, when poster presenters should be at their poster to answer questions.
- **Bring your poster file (pdf or PowerPoint) to the Speakers' Table on a CD or USB drive** during morning registration on October 2. If you are unable to do this, contact Elizabeth Brusati prior to the Symposium to make other arrangements.
- **Consider submitting an article to the Symposium Proceedings.** (Those entering the Student Poster Contest are required to submit a Proceedings article.) Instructions below.

Student Presenter Contest

We invite graduate and undergraduate students to present their work in the first-ever Cal-IPC Symposium Student Presenter Contest! The contest is for both oral and poster presenters, with a \$250 first-place prize for the top presenter in each category. First, 2nd and 3rd prize will be recognized in *Cal-IPC News*.

*New for
2008!*

- **Indicate that you are entering the contest** when you submit your abstract. Enter either an oral or poster presentation, but not both.
- **Follow the poster and talk instructions above.**
- **Entrants must submit an article to the Symposium Proceedings by September 19** following instructions below. Failure to submit this article will disqualify you from the contest.
- **Student Contest talks** will be judged in their own session(s).
- **Student Contest posters** will be judged both during the poster session and at other times.
- **Entries will be judged on** the quality of the research, presentation, and question session. All presenters will receive feedback from the judges after the Symposium.

Proceedings

Since 1995, Cal-IPC Symposium Proceedings have provided a valuable resource for land managers and researchers seeking information on invasive plants in California. For many projects, the Proceedings form the only public record of the work! **In 2008, all speakers are required to submit an article of 1000-1500 words (4-6 pages double-spaced) by Friday, September 19. Note that this is two weeks prior to the Symposium.**

The Proceedings are fundamentally important to the goals of the Symposium. They help fulfill our mission of educating our members and the public. Your information becomes a permanent part of the online Symposium archive, providing a great reference tool for the weed worker community for years to come. All articles are coded so that they can be accessed by keyword. Currently, article references are being added to [Plant Profile](#) pages for each plant.

For presenters, getting published can help your career, and it helps build credibility among your peers. And preparing a written document helps organize what you want to communicate in your presentation.

Instructions

- **Format your submission according to the template posted** at www.cal-ipc.org/symposia/presenters.php. (The template follows standard scientific manuscript format—Abstract, Introduction/Research Question, Study Site and Methods, Results and Discussion, and Literature Cited. If your presentation does not fit well with these guidelines—e.g. you're reporting on an outreach program—modify the format to be most suitable.) Submission should be 1000-1500 words (not including title and authors), and sent as a Word (or Word-compatible) file to edbrusati@cal-ipc.org.
- **You may also submit up to three graphics** (tables, graphs, photographs). These should be sent as separate files. Please keep in mind that we may need to reduce your graphics in the publication. Graphics may use color.
