NNF & Prop 84 Big Tujunga Projects



In late August 2009, an arson-caused fire ignited in the Angeles National Forest, just north of the city of Los Angeles. In days, the Station Fire grew to become the largest fire in L.A. County's history, burning more than 161,000 acres – 25 percent of the Angeles National Forest. The fire affected four watersheds, decimated forests, and severely impacted both public and private infrastructure.

The LA Corps through Grants from the National Forest Foundation & the CCC Prop 84 is helping to restore this section of forest with the rebuilding of trails and the removal of invasive plant species

Accomplishments – March 2013 to Present

Non-Native Vegetation Removal :

Approximately over 40 acres of watershed improvement and restoration completed & 4.5 miles of stream improvements within the Big Tujunga Watershed

Trail Restoration

 Approximately 35 miles of trails have been restored within the Big Tujunga Watershed



2013 & 14 Accomplishments



Non-Native Vegetation Removal in the following areas:

- Spanish Broom removal performed within Trail Canyon
- Spanish Broom removal performed at Shortcut
- Spanish Broom removal performed off of Big Tujunga Road
- Spanish Broom removal performed at and around Camp 16 off of Mt C Gleason Road
- Sweet Clover removal at Mill Creek, starting at Monte Cristo CG working south
- Spanish Broom Removal performed on Josephine Fire Road
- *The main challenge is the amount of Poodle-Dog Bush the crews are working around while performing Spanish broom removal.
