Waiver of Liability, Assumption of Risk, & Indemnity Agreement

Waiver: In consideration for being allowed to participate in any way in all activities, including travel to, from, and during activities of the California Invasive Plant Council's 2019 Symposium (10/15/19-10/18/19), including the Trainings and Field Trip, hereinafter called "Symposium", I, for myself, my heirs, personal representatives or assigns, do hereby release, waive, discharge, and covenant not to sue the California Invasive Plant Council, its officers, employees, directors, volunteers and agents from liability from any and all claims, including the negligence of the California Invasive Plant Council, its officers, employees, directors, volunteers, and agents, resulting in any personal injury, accidents or illness (including death), property loss, and economic or emotional loss arising from, but not limited to, participation in Symposium.
