Challenges:

- Many invasive threats and not enough resources to manage all of them everywhere
- Well-established habits of focusing on the same species, in the same areas, in the same ways - doing what we have always done
- Rarely give ourselves time to collectively reflect: are we focusing on the right things in the right places?
- Sometimes lack expertise in invasive species ecology or management










Invasive Plant Workshops:

- 2-day: refuge staff, partners, local landowners, invasive species experts
- Review invasive plant management history
- Prioritize species and areas
- Meets critical elements of a strategic and adaptive approach to invasive plant management



The Prioritization Process

Compile Species and Areas

- Compile list of species: current and potential future
- Identify management areas (geographic, thematic)
- Gather site-specific info: sensitive resources, hydrology, infrastructure, +

Rank Species and Areas

- Engage others: staff, partners, local and regional experts
- Invasive plant inventory and early detection prioritization tool

Review and Document

- Review and refine results as needed
- Document methods and results

Species Ranking Criteria

Larger Landscape Invasiveness Ranking

- Existing larger landscape risk assessment rankings
- Cal-IPC Inventory, Alaska, Virginia, NatureServe, +

Site-specific Invasive
Species Status and Habitat
Suitability

- Species proximity
- Current abundance and distribution (perceived)
- Potential to spread

Site-Specific Ecological Impacts

• Current or potential impacts to natural resources of conservation concern

Legal Mandates

• Larger landscape management importance

Area Ranking Criteria

Site Characteristics

- Ecological integrity
- Innate resistance to invasion
- Conservation importance

Invasive Plant Status

- Infestation level
- Number of invasive species
- Survey knowledge

Invasion Risk

- Vectors and vector pathways
- Public use
- Anthropogenic disturbance


- 187,000 acres

- Oregon Department of Agriculture






Malheur NWR

- Workshop Results:
 - ✓ Regained institutional knowledge
 - New staff and lost data
 - ✓ Renewed coordination (county/state)- EDRR
 - ✓ Prompting to investigate suspicious/alarming EDDMapS reports within the county

- ☐ Promote a more strategic and adaptive approach to invasive species management
- Operational continuity (results are documented)
- ☐ Often leads to follow-up inventory or early detection survey effort



Learning and Adapting the Process:

- Manageable list of species to prioritize
 - Suggest <50 (ideally <30), pre-workshop filtering
- **Partner/expert participation is critical:** diverse representation – invasive species, ecosystem/sensitive species experts, IPM experts
- **Be flexible!** Each situation is different: adapt prioritization process to meet local needs >document
- **Facilitation: a balancing act** between great discussions and achieving workshop objectives


