WE MAINTAIN TOOLS, SUCH AS THE INVENTORY OF INVASIVE PLANTS IN CALIFORNIA AND CALWEEDMAPPER, THAT PROVIDE IMPORTANT INFORMATION ON THE RISKS AND SPATIAL DISTRIBUTION OF INVASIVE PLANT SPECIES. WE ARE PRODUCING BEST MANAGEMENT PRACTICES GUIDANCE ON CONTROLLING INVASIVE PLANTS, RESULTING IN THE NEW WEEDCUT ONLINE TOOL HOSTED BY THE UNIVERSITY OF CALIFORNIA AGRICULTURE AND NATURAL RESOURCES. WE CONDUCT RESEARCH ON THE IMPACTS OF INVASIVE PLANTS TO RARE NATIVE PLANTS, INCLUDING THE ROLE OF CLIMATE CHANGE, TO HELP LAND MANAGERS SET PRIORITIES. TO HELP MANAGERS GET AHEAD OF THE GAME WITH NEW WEEDS, WE LEAD AN EFFORT WITH COLLEAGUES IN ARIZONA, OREGON, NEVADA, AND WASHINGTON TO PROACTIVELY EVALUATE THE RISK OF PLANTS

WE PROVIDE TRAININGS FOR CONSERVATION CORPS MEMBERS AND PARTICIPATE IN AN ECOLOGICAL WORKFORCE DEVELOPMENT EFFORT AS PART OF THE CALIFORNIA BIODIVERSITY NETWORK. OVER 600 PEOPLE ATTENDED OUR 2023 SYMPOSIUM, WITH THREE DAYS OF PRESENTATIONS, TRAININGS, AND DISCUSSION GROUPS.

ONE FOCUS IS SECURING FUNDING FOR COLLABORATIVE INVASIVE PLANT MANAGEMENT PERFORMED BY COUNTY WEED MANAGEMENT AREAS (WMAS). WE ALSO TRACK BILLS IN THE LEGISLATURE THAT ARE RELEVANT TO EFFECTIVE LAND STEWARDSHIP, WORKING WITH AUTHORS AND COMMITTEES TO AMEND LANGUAGE AS NEEDED. THE STATE'S INTERAGENCY INVASIVE SPECIES COUNCIL AND ITS ADVISORY COMMITTEE WERE CREATED VIA LEGISLATION SPONSORED BY CAL-IPC, AND WE ACTIVELY TRACK AND SUPPORT THEIR EFFORTS.
