WE MAINTAIN TOOLS, SUCH AS THE INVENTORY OF INVASIVE PLANTS IN CALIFORNIA, CALWEEDMAPPER, AND WEEDCUT THAT PROVIDE IMPORTANT INFORMATION ON THE RISKS AND SPATIAL DISTRIBUTION OF INVASIVE PLANT SPECIES. WE RESEARCH THE IMPACTS OF INVASIVE PLANTS TO RARE NATIVE PLANTS TO HELP LAND MANAGERS SET PRIORITIES. WE LEAD AN EFFORT WITH COLLEAGUES IN ARIZONA, OREGON, NEVADA, AND WASHINGTON TO PROACTIVELY EVALUATE THE RISK OF PLANTS BECOMING INVASIVE IN THE FUTURE. WHERE WE CAN ADD VALUE, WE STEP IN TO PROVIDE COORDINATION FOR REGIONAL IMPLEMENTATION PROJECTS, SUCH AS THE INVASIVE SPARTINA PROJECT IN SAN FRANCISCO BAY.

WE PROVIDE TRAININGS FOR CONSERVATION CORPS MEMBERS AND PARTICIPATE IN AN ECOLOGICAL WORKFORCE DEVELOPMENT EFFORT AS PART OF THE CALIFORNIA BIODIVERSITY NETWORK. OVER 600 PEOPLE ATTENDED OUR 2024 SYMPOSIUM, WITH THREE DAYS OF PRESENTATIONS, TRAININGS, AND DISCUSSION GROUPS.

ONE FOCUS IS SECURING FUNDING FOR COLLABORATIVE INVASIVE PLANT MANAGEMENT PERFORMED BY COUNTY WEED MANAGEMENT AREAS (WMAS). WE ALSO TRACK BILLS IN THE LEGISLATURE THAT ARE RELEVANT TO EFFECTIVE LAND STEWARDSHIP, WORKING WITH AUTHORS AND COMMITTEES TO AMEND LANGUAGE AS NEEDED. THE STATE'S INTERAGENCY INVASIVE SPECIES COUNCIL AND ITS ADVISORY COMMITTEE WERE CREATED VIA LEGISLATION SPONSORED BY CAL-IPC, AND WE ACTIVELY TRACK AND SUPPORT THEIR EFFORTS.
